#### Hans Christian Andersen

A children's author who was known for his fairy tales, such as "The Little Mermaid," "The Ugly Ducking," and "The Emperor's New Clothes."

#### **Ludwig Van Beethoven**

A talented classical composer.

#### Admiral Richard E. Byrd

Was labeled "unfit for service" as he retired from the Navy. After he flew over both the North and South Poles, they allowed him to return to the service.

#### **Winston Churchill**

Young Churchill failed the sixth grade and later became a great statesman and Prime Minister of Great Britain.

#### **Tom Cruise**

Actor, who starred in movies such as Top Gun, Mission Impossible, Rainman, and many more.

#### Leonardo Da Vinci

An artist, engineer and humanist from the Italian Renaissance.

# **Program Description:**

Disability Services is the official contact for students with disabilities who request academic adjustments, reasonable modifications, auxiliary aids, and/or services to provide equal opportunity for academic success. The Office of Accessibility Services (OAS) serves as an advocate for students and will assist in achieving equal access to all college programs and services. Services provided are: assistance with registration, academic advising/counseling, computer/adaptive devices, physical accommodations, tutoring, sign language interpreters, readers/scribes, note-taking supports, large-print, books in an alternative format, testing accommodations including: reader/ scribe software, distraction reduced testing environment and extra time for testing.

To receive accommodations, students must have a Clark State student ID number. The first step is to complete the Accommodation Request Form found on our website. Documentation can be uploaded after clicking "submit" on the Accommodation Request Form. Next, students will meet with OAS to discuss individual needs and determine appropriate accommodations. Documentation of the disability may include the following: IEP - Individualized Education Plan, MFE - Multifactored Evaluation, or other testing information; a letter from your doctor or other licensed professional, or pictures of prescribed medications. OAS, in consultation with the department faculty as needed, will work with you to determine specific academic adjustments, reasonable modifications, auxiliary aids, and/or services that will be required. It is your responsibility to meet with OAS and/or the instructors at the beginning of each semester to discuss arrangements for academic adjustments, reasonable modifications, auxiliary aides, and/or services in each course.

# **Program Description:**

The mission of Disability Services (DS) is to enhance each student's individual educational experience by preventing students at Edison Community College from discrimination on the basis of disability. Reasonable accommodations are provided to eligible students with disabilities who request them, in compliance with Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act (ADA).

Rights of Eligible Students with Disabilities:

Students registered with Disability Services ...

- Have the right to appropriate accommodations after providing DS with appropriate documentation of your disability and determining appropriate accommodations with the Coordinator of Disability Services.
- 2. Have the right to confidentiality. Documentation of your disability is privately kept within DS and is not part of your academic record. Records and information about you are kept confidential unless you agree to release them in writing and except as required, to prevent clear and imminent danger to the student or others or when legal requirements require that confidential information be revealed.
- 3. Have the right to advocacy support from DS when you have made known your need for an approved accommodation to a faculty or staff member and have not received it.
- 4. Have the right to file a grievance if you feel that your right to an appropriate accommodation isn't being met. If you feel that DS is not satisfactory in working with you to obtain accommodations, you may meet with the Dean of Student Success to discuss your concerns. A student complaint form is available from Edison's website at www.edisonohio.edu/ in the Student Handbook.
- 5. Have the right to file a civil rights suit through the Office of Civil Rights, U.S. Department of Education if you are not satisfied with the services provided to you by the college. The Office for Civil Rights (OCR) within the Department of Education (ED) protects the rights of students in educational programs or activities that receive financial assistance from the ED. Under these laws, ED-funded programs and activities must be operated in such a manner that ensures that people who meet the program's qualifications and eligibility requirements are given equal opportunity to participate, regardless of their race, color, religion, national origin, sex, age, or disability.

Duties of Eligible Students with Disabilities:

Students registered with Disability Services have a duty to...

- 1. Register with DS and provide documentation of your disability to be eligible for any accommodation from the college.
- 2. Contact DS in a timely manner for assistance in identifying accommodations and supports and how to get them.
- 3. Inform DS if you are uncertain of the accommodations and services you need or having difficulty getting what you have requested.
- 4. Contact DS and complete a Self-Identification (Self-ID) letter which is evidence of your eligibility for accommodations every semester. Present the Self-ID letter to your instructor and discuss the specifics of your accommodations in each class. \*You must do this every semester. \*
- 5. Request classroom and testing accommodations in a timely manner from faculty at least one week in advance.

#### **Available Services**

Services are tailored to fit each individuals needs. Services and accommodations that may be available include:

- · Academic advising
- · Accessible parking
- Testing extended time, distraction-reduced environment, reader, scribe
- · Note-taking assistance
- · Materials in alternative formats audio format, e-book format
- Adaptive technology recorder, headphones, personal FM device, classroom furniture adjustments, etc.
- · Interpreters, c-print, or real-time captioning

# **Eligibility Requirements:**

A "qualified person with a disability" is someone with a physical or mental impairment that substantially limits one or more major life activities, who with or without accommodations can meet the essential requirements for participation in a program.

- Have a disability
- Self-identify the disability & need for accommodations to DS
- · Provide documentation of the disability to DS

# **Applying for Disability Services**

Students with disabilities must submit the application for services to the Coordinator of Disability Services. The Application for Services form is available in Student Services at 937.778.8600, or online at www.edisonohio.edu/disability.

You should do this as soon as you have been accepted for admission. Contact DS at least four weeks before the semester you are enrolled to secure services for that semester.

#### **General Documentation Guidelines**

DS asks for copies of documentation of the student's disability whenever available. Recent high school graduates should bring a copy of the most recent IEP and ETR.

In general, documentation should:

- Be current, preferably within the last three years. The age of acceptable documentation is dependent upon the disabling condition, current status of the student, and/or nature of specific request for accommodation.
- Include verification of diagnosis and severity and longevity of the disabling condition from a
  qualified treating professional provided by the student.
- Include functional limitations describing how the impairment significantly limits a major life activity in an educational setting.

If you do not have documentation that meets these guidelines, please contact the Coordinator of Disability Services personally to discuss your options.

## Confidentiality

Information regarding a student's disability is confidential. Any documentation and verification of a disability is kept separate from academic records and is not shared with anyone outside of DS without the permission of the student, and then only when "the need to know" is understood and granted by the student.

# **Program Description:**

Accessibility resources services are provided for students with permanent, chronic, or temporary conditions. # **Program Description:**

Accommodative Services provides support services, information, and guidance to students with disabilities. Services available include (but are not limited to) testing accommodations (extended time, reduced distraction), and classroom accommodations (taped lectures, note-taking assistance, alternative format textbooks). Accommodative Services can also refer students to the Academic Success Center for workshops regarding time management, managing test anxiety, and study skills. All students must first meet with Accommodative Services in order to understand the process and provide any required documentation. Rhodes State College has designated disability parking areas in close proximity to campus buildings so that students who display State of Ohio handicap placards can move more easily from the parking area to various areas on campus. External ramps and power doors also allow students access to buildings. All multi-story buildings are equipped with elevators. The campus is equipped with restroom facilities, lowered water fountains, and lowered pay telephones.

Academic accommodations (like testing and classroom accommodations) are provided to students with a documented disability. Students who require services should contact Accommodative Services as soon as possible to provide current documentation (IEP, ETR, documentation from a treatment professional, etc.) and/or medical records to Accommodative Services in the Technical Education Laboratory building Room 132 (TL132). After notification that documentation is complete, the student must meet with Accommodative Services staff to discuss reasonable accommodations.

# **Program Description:**

The mission of Student Accessibility Services (SAS) is to provide assistance to students with varying degrees and types of disabilities in order to enhance their academic potential and to minimize any physical and attitudinal barriers they might encounter at Kent State University. Kent State University Regional Campuses are also committed to improving access to all aspects of university life.

Types of disabilities of students who receive services through Student Accessibility Services include, but are not limited to:

- Chronic health and medical disabilities
- Hearing disabilities
- Mobility disabilities
- Physical disabilities

- Psychological/psychiatric disabilities
- Specific learning disabilities
- · Temporary disabilities
- · Visual disabilities

The services and accommodations students receive are based upon specific information provided in documentation. These services might not always be the same as those provided in public schools or at other educational institutions. Accommodations are determined at your campus to provide you with accessibility to campus facilities, academic programs, and classroom/instructional activities.

Your responsibility as a student with a disability:

The faculty and staff at Kent State Regional Campuses will make every effort to help you be successful at the University. However, you also need to take an active role in your education and voice your concerns and questions so that they may be addressed by the SAS office and your professors. You will always be your best advocate, but SAS is here to assist you in the process as needed.

By accepting responsibility as a partner in your education, you also must:

- Self-monitor your academic progress
- Meet University academic and specific program standards
- Provide each of your instructors each semester with your letter of accommodation so that they know how best to assist you
- Initiate your requests for accommodations in a reasonable time so that your accommodations can be in place in a timely manner
- Adhere to policies stated in the Student Digest of Rules and Regulation, including policies about student conduct
- Adhere to policies stated in the "SAS Student Handbook" for regional campus students with disabilities

To receive services for students with disabilities at Kent State University Regional Campuses are based on documentation. To be eligible, students must provide SAS with information from a qualified doctor, psychologist, or other appropriate professional. The information must meet state and federal guidelines for indicating the presence and severity of a disability. It is the student's responsibility to provide SAS with this documentation. The University cannot provide services until you submit your documentation, and it is approved.

Along with providing documentation, you must schedule an appointment with the SAS professional on your campus to officially register with SAS and sign forms authorizing services. The University cannot provide services until you meet with SAS, and we officially register you with SAS. Appropriate and reasonable accommodations are based on your individual needs. Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990 (ADA).

As required by law, disability documentation and the nature of your disability are confidential between you and SAS. You may choose to reveal this information or to give permission to release this information. It is against the law and inappropriate to make explicit or implicit reference to your disability without your permission.

# **Program Description:**

Since 1983, the PLUS Program at Muskingum University has provided comprehensive academic support services for college students with learning differences to foster the development of skills essential for success in college. PLUS Program students typically have a documented diagnosis of learning disability, ADHD, autism spectrum disorder, or any other documented disability that creates a learning difference. Students must apply and be accepted to Muskingum University to be eligible for the PLUS Program.

A fee-for-service program, the PLUS Program offers four levels of services to meet each student's unique learning needs.

- The Premier level of service is 5 hours per week, and the Select level of service is 3 hours per week. The Premier and Select levels of service provide content tutoring using various learning styles and focus on the development of academic strategies needed for success.
- The **Transition** level of service is 1 ½ hours per week and is designed for students who need support in transitioning from high school to college or from college to life after college.
- The **Connections** level of service is 3 hours per week and focuses on the development of self-advocacy, communication, and social skills, and includes a peer mentor to support social skills development.
- For students who need both academic and social skills support, the Select and Connections levels of service can be "Bundled" for 6 hours per week.
- Because the PLUS Program's goal is to support students in fostering independence and developing skills necessary for success in college, students may reduce their level of services during their years with the PLUS Program.

Each PLUS Program student meets individually during regularly scheduled times with assigned Professional Learning Consultants who customize learning strategies within content tutoring and empower students to develop academic, communication, and executive functioning skills. Learning Consultants have a bachelor's degree in the area they are tutoring and collaborate with the student's instructors, academic advisors, and families to monitor academic progress and provide the support needed for success in college. Each student has one "primary" Learning Consultant who oversees the student's entire academic experience and serves as the main contact with the student's family.

Another service of the PLUS Program, the **LEAP Program** provides a bridge to support students' transition from high school to college. Designed for new first-year students, this program provides an opportunity for students to experience a three-credit college course during the two weeks before the fall semester begins as well as move into their residence hall room early to learn the campus layout and connect with other LEAP students and upper-class mentors.

Student Accessibility Services also supports students with learning differences by ensuring equal access to campus programs and services as required by the Americans with Disabilities Act (ADA). Students must request accommodations by submitting professional documentation of their disability. Student Accessibility Services determines appropriate accommodations based on the student's documentation of their learning differences and their designated limitations to learning. Each semester, Student Accessibility Services sends an email notification to each student's instructors of the approved accommodations while keeping the student's disability diagnosis confidential. Students are encouraged to meet individually with their instructors to discuss their accommodations. However, Student Accessibility Services makes the first contact with instructors and continues to advocate for students as needed. Students are not required to participate in the PLUS Program to receive accommodations through Student Accessibility Services.

# **Program Description:**

The Office for Disability Services (ODS) collaborates with students with documented disabilities and instructors to provide reasonable accommodations, auxiliary aids, and support services that are individualized and based upon disability documentation, functional limitations, and a collaborative assessment of needs. Students are taught to use advocacy skills to request authorized accommodations specific to class needs and personal preferences. ODS may not be able to meet all personal preference requests but does provide reasonable accommodations/auxiliary aids. One of the critical differences between high school and college is that students need to be involved in service decisions and request accommodations. Note: ODS does not provide personal assistance or equipment, i.e., homework assistance, typing, personal laptops, personal aids, etc. There are five main service areas at ODS: exam accommodations, alternative media, sign language interpreting/ transcribing services, assistive technology training center, disability counseling, and advocacy services.

In order to fully evaluate requests for accommodations or auxiliary aids and to determine eligibility for services, the OSU ODS requires disability documentation. The documentation should include an evaluation by an appropriately qualified professional that makes evident the current impact of the disability as it relates to the accommodation(s) requested. The eligibility determination process is not a same-day process. Once documentation is received, it will be reviewed in order of receipt; therefore, it is recommended that documentation be submitted well in advance of any accommodation-related needs (e.g., exam accommodations and alternative media services). As documentation provision is a critical component to securing service through ODS, counselors are available and willing to answer questions concerning this process.

# **Program Description:**

The mission of Student Accessibility Services (SAS) is to ensure equal opportunity and access for members of the Ohio University community. Central to this mission is the development of an academic environment that is accessible to all people without the need for adaptation. While working toward the goal of full inclusion, accommodations must still be provided on an individual basis.

#### **Accommodations**

Appropriate accommodations are determined through the individual intake appointment by reviewing documentation, discussion with the student, and evaluating the essential requirements of a course or program. After the intake appointment, a student will have approved accommodations available for use at their discretion.

Please Note: SAS does not provide services of a personal nature such as attendant care, homework assistance, and typing services.

While accommodations are determined on an individual basis, below are some examples of commonly approved accommodations:

Assistance with notetaking
Extended time for test taking.
Flexibility with spelling or grammar errors
Materials in an alternate format
Reduced distraction location for test-taking
Reader for exams
Scribe for exams
Audio recording of lectures
Use of a non-graphing calculator
Use of a word processor for essay exams

#### Resources

Ohio University provides many resources to all students that might also be of interest to students with disabilities. These resources include: access to individual counseling, tutoring, technology support, and study strategy courses.

To be eligible for Student Accessibility Services, a student must:

- Submit disability documentation (as described below) and a completed Application for Accessibility Services.
- Receive notification from an Accessibility Coordinator (AC) that you are eligible.
- Schedule and attend an intake appointment with your assigned Accessibility Coordinator During the intake meeting, the student and AC will determine accommodations and discuss assistive technology or potential support services around campus that may be of assistance to the student.

#### **Documentation**

Accessibility Coordinators review documentation and determine eligibility according to the framework of the Americans with Disabilities Amendments Act and in accordance with the professional standards of the Association of Higher Education and Disability. There is no "exact formula" of how to document or determine a disability; however, here are the things Ohio University looks for in documentation:

- · Chronic physical or mental condition that has been diagnosed
- Evidence that the condition significantly impacts one or more major life activity (such as seeing, learning, standing, etc.) provided by a medical, mental health, or educational professional qualified to diagnose, evaluate, and treat the condition
- · Demonstrates a history of accommodation
- Impact on current functioning supports the accommodations being requested

Additionally, tutoring and assistance through the Writing Center, the Math Lab, and Supplemental Instruction (SI) are provided to all Otterbein students by the ASC.

Documentation from a student's previous school (verifying the diagnosis, the functional limitations, and the recommendations for/history of accommodations) is typically sufficient. A one-page registration form is available on the Disability Services website if a student does not already have documentation. While students may submit documentation and register at any point, we suggest that they do so prior to their first semester when possible. Additionally, informational meetings are available for future and current Otterbein students throughout the year to discuss the process and potential accommodations. 
